*NOTIFICATION*

In pursuance of Clause (ii) of paragraph 3 of the Foreigners (Restricted Areas) Order, 1963, and in supersession of the notification of the Government of India in the Ministry of Home Affairs No. S. O. 1337, dated the 10<sup>th</sup> May, 1963, the Central Government hereby authorises in respect of each of the territorial units or the restricted areas specified in column (1) of the Schedule hereto annexed, the officer or officers specified against it in column (2) thereof to issue permits under the said paragraph to foreigners entering into or residing in any restricted area within the territorial unit, or the restricted area, as the case may be.
